Terms & Conditions - 2024

By entering the competition, you agree to the following Terms & Conditions:

- a. The AMCS Art Against Ageism Competition is open to all ages.
- b. A parent or guardian must apply on behalf of the entrant if the entrant is under 18 years old
- c. Entrants may enter an unlimited number of submissions however each submission requires a separate entry form
- d. There is no entry fee for submission.
- e. Deadline for entries is Sunday 8 September 2024, 11:59pm (Melbourne Time)
- f. AMCS will award one first-place winner, one runner-up, and 10 finalists
- g. The number of finalists is at the sole discretion of the judging panel
- h. Copyright of the artwork remains the property of the artist
- i. AMCS will use personal information collected in the submission process to contact entrants and will be handled according to the Privacy Act.
- j. j. The entrant acknowledges and agrees that as part of the application process, they will provide personal information such as name, email address, phone number, age if under 18 years, and country of residence. The entrant acknowledges and agrees that AMCS, Merri Health, Carers Victoria, Language Loop, and Elder Rights Advocacy may use the artwork for marketing purposes.
- k. Australian Multicultural Community Services reserves the right to substitute judges.
- The judges' decision is final, and no correspondence will be entered into
- m. Successful entrants will be advised by phone and/or email that their artwork has been awarded one of twelve prizes.
- n. Entrants agree to indemnify Australian Multicultural Community Services Ltd against any potential loss or legal action arising from the artwork they submit.
- o. By entering the AMCS Art Against Ageism competition, the entrant confirms that they are the creator and owner of the work, that the entrant has the permission of the subject, or, where appropriate, the subject's parent/guardian, that the work does not infringe copyright or indigenous culture and intellectual property, that Artificial Intelligence (AI) was not used, the entrant resides in Australia, the submission was not taken in circumstances of trespass or invading anyone's legal right of privacy, confidentiality, breach of industrial law or applicable industry code and does not to the best of their knowledge defame anyone nor was their conduct in creating the submission likely to be misleading or deceptive and that they agree with these Terms & Conditions
- p. All terms and conditions may be updated at Australian Multicultural Community Services' discretion
- q. Australian Multicultural Community Services is entitled to exclude or remove from the AMCS Art Against Ageism Competition 2024 any submissions by an entrant who has submitted false information or who does not comply with all Terms and Conditions set out by Australian Multicultural Community Services.
